



1 GENERAL INFORMATION

Refro40 is a calcium aluminate cement product which is specifically designed for refractory producers by Çimsa Research and Application Center.

Refro40 offers various advantages to refractory applications such as;

- Thermal resistance up to 1250 °C,

- Resistance to acid and alkaline,
- High early and final strength,
- Easy application in winter conditions even under the freezing point (up to -5°C).

3 PRODUCTION

Çimsa Aluminates products are produced in L-shaped kilns by fused method with the special cooling system. After cooling, clinker is ground in ball mills and packaging is done.

9 STORAGE CONDITIONS AND SHELF LIFE

Refro40 must be stored in dry and sheltered conditions, in its original, tightly sealed packaging. When stored under these conditions, the product retains its properties for up to 12 months. No more than 10 bags or 2 pallets should be stacked on top of each other. The product should always remain in its original packaging, and when not in use, the package must be tightly sealed.
